AND DISPENSING WITH A SECOND READING**

WHEREAS, the Village of Georgetown has advertised for sealed bids for the Village of Georgetown 2016 pavement project pursuant to Ohio law (the "Project"); and

WHEREAS, all bids in connection with the Project have been opened and read aloud on the date and time specified in such advertisement; and

WHEREAS, the bid of Brown County Construction in the amount of \$138,731.00 was the lowest and best bid received.;


NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Georgetown, Brown County, Ohio, a three fourths majority of all members thereof concurring that;

Section 1. The bid of Brown County Construction Inc. in the amount of \$138,731.00 is hereby determined to be and is accepted as the lowest and best bid received in connection with the 2016 Paving Project.

Section 2. The Village Administrator is authorized and directed to enter into a contract on behalf of the Village of Georgetown with Brown County Construction Inc. in furtherance of the 2016 Paving Project in the amount of \$138,731.00 in accordance with the specification on file in the Village offices.


Section 3. That the Village Council does hereby dispense with the requirement that this Resolution be read on two separate days, pursuant to Section 731.17(A)(2) of the Ohio Revised Code, and authorizes the adoption of this Resolution upon its first reading.

You are hereby notified that your BID has been accepted for items in the amount of \$138,731.00.


