WHEREAS, all bids in connection therewith having been duly opened and read aloud on the date and time specified in such advertisement; and


WHEREAS, it appearing to Council that the bid of Brown County Construction Co., INC.. in the amount of \$148,182.00 was the lowest and best bid received;

We have reviewed the Bids received on July 22, 2015 for the Street Paving project. The bids are as follows:

Brown County Construction Company, Inc.	\$148,182.00

The low bidder is Brown County Construction Company, Inc, 8108 U.S. Route 52 West, Aberdeen, Ohio 45101. After review of their bid, we see no irregularities. We have contacted Brown County Construction Company, Inc. and they are comfortable completing the job by August 19 and have stated it should take them two days to complete. It is our opinion that the low bidder has the experience and qualification to perform the required work. We recommend awarding the Street Paving Project to Brown County Construction Company, Inc.
