**A RESOLUTION AUTHORIZING THE ADMINISTRATOR TO ENTER
INTO AN AGREEMENT FOR THE PURCHASE OF
AN AMBULANCE FROM 911 FLEET & FIRE EQUIPMENT**

WHEREAS, the Village of Georgetown seeks to purchase a used 2007 Braun Chieftain XL Ambulance on a GMC chassis from 911 Fleet & Fire Equipment for use by the Village of Georgetown Fire Department.


NOW THEREFORE BE IT RESOLVED by the Council of the Village of Georgetown, Brown County, Ohio, a majority or more of all members thereof concurring as follows:

SECTION 1: The Administrator is authorized to enter into and execute a contract in the amount of Thirty Five Thousand Dollars and 00/100 (\$35,000.00) for the purchase of a used 2007 Braun Chieftain XL Ambulance on a GMC chassis from 911 Fleet & Fire Equipment. A copy of the price quote is attached as Exhibit A and incorporated herein by reference.

SECTION 2: That the Council hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of the Council, and that all deliberations of this Council and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3: This Resolution shall be in full force and effect from and after the earliest date allowed by law.
