RESOLUTION 1324

A RESOLUTION ACCEPTING THE BID OF FORD DEVELOPMENT CORP. FOR THE NORTH MAIN STREET WATER MAIN REPLACEMENT PROJECT AND AUTHORIZING THE VILLAGE ADMINISTRATOR TO EXECUTE AN AGREEMENT FOR THE PERFORMANCE OF THE WORK

WHEREAS, the Village of Georgetown (the “Village”) seeks to replace the North Main Street water main (the “Water Main Replacement Project”); and

WHEREAS, the Village publicly advertised for the Water Main Replacement Project and received bids and chose to select the base bid with alternative #1; and

WHEREAS, the lowest and best bidder has been determined to be Ford Development Corp. in the amount of \$822,087.00.

THEREFORE, BE IT RESOLVED, By the Council of the Village of Georgetown, Brown County, Ohio, a majority or more of all members thereof concurring as follows:


SECTION 1: Council hereby determines that the lowest and best bidder for the Water Main Replacement Project is Ford Development Corp. whose bid is \$822,087.00 for the base bid with alternative #1.

SECTION 2: The Village Administrator is authorized to enter into and execute an agreement with Ford Development Corp. in the amount of \$822,087.00 for the Water Main Replacement Project (the “Agreement”). A copy of the Agreement is attached as Exhibit A and incorporated herein by reference.

SECTIONS 3: That the Council hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of the Council, and that all deliberations of this Council and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including section 121.22 of the Ohio Revised Code.

SECTION 4: This Resolution shall be in full force and effect from and after the earliest date allowed by law.

The Contract Price of the awarded Contract is: \$822,087.00



1. Deliver to Owner the Agreement, fully executed by Bidder.
2. Deliver with the executed Agreement the Contract security and insurance documentation as specified in the Instructions to Bidders and General Conditions, Articles 2 and 6.

Failure to comply with these conditions within the time specified will entitle Owner to consider you in default, annul this Notice of Award, and declare your Bid security forfeited.

Within ten days after you comply with the above conditions, Owner will return to you one fully executed counterpart of the Agreement.
